FIRST ORDER OF BUSINESS

Call to Order/Roll Call

Ms. Cerbone called the meeting to order at 2:04 p.m.

Supervisors McConn, Kane and Dare were present. Supervisors Reid and Harding were not present.

THIRD ORDER OF BUSINESS

Ms. Cerbone presented Resolution 2024-43.

Staff Reports

A. District Counsel: Kilinski | Van Wyk PLLC

Ms. Kobitter presented the Memorandum explaining the new requirement for special districts to develop goals and objectives annually and develop performance measures and standards to assess the achievement of the goals and objectives. Community Communication and Engagement, Infrastructure and Facilities Maintenance, and Financial Transparency and Accountability will be the key categories to focus on for Fiscal Year 2025. She presented the Performance Measures/Standards & Annual Reporting Form developed for the CDD, which explains how the CDD will meet the goals. She recommended changing the Standard for Goal 1.1 to reduce the number of board meetings during the Fiscal Year, from eight meetings to two meetings.

On MOTION by Mr. McConn and seconded by Ms. Kane, with all in favor, the Goals and Objectives and the Performance Measures/Standards & Annual Reporting Form, as amended, were approved.

• Update: CDD Boundary

Mr. White stated that, in reviewing his firm's records, it was confirmed that Mr. Justin Pickerel sent the new sketch including the new CDD boundaries.

CANOE CREEK RESERVE CDD

September 17, 2024

Ms. Cerbone stated that, during one of the Public Hearings, all the Mailed Notices were included in the Agenda and three came into question. One Mailed Notice was sent to a governmental entity and two Mailed Notices were sent to separate private property owners. Her understanding is that those three parcels are not within the CDD boundaries so no action needs to be taken with regard to CDD boundaries. In an abundance of caution, when considering legal requirements, District Management included three additional parcels that did not need to receive Mailed Notices in advance of the public hearing.

Ms. Kobitter and Mr. White were in agreement.
